

IMPORTANT INFORMATION

Damages & Cleaning

Any damages that occur to the venue during the time of your event may incur damage and cleaning fees as deemed by the Hotel. Should any damages occur to the venue including that of; excessive glass breakage, carpet damage (spilling of drinks, vomiting etc.) and / or furniture & equipment damage, cleaning and damages fees will apply.

Fire & Smoke

The DoubleTree by Hilton Perth Waterfront is a 100% smoke free zone. Sparklers, smoke machines, candles or emitters of any kind are not permitted within the venue.

Music / Entertainment

All speakers present in the 18 Knots Rooftop Bar are set to Hilton music channels. Speakers cannot be isolated or muted. There is no access to power on the 18 Knots Rooftop Bar Balcony. Dls and other entertainment or equipment is not recommended in the space.

18 Knots Rooftop Bar "Balcony"

Should harsh weather conditions prevent your function from proceeding, i.e. rain, storm, heavy winds etc. the Venue will do it's upmost to relocate your event to an alternative suitable function space. Should another simultaneous booking be taking place within the Rooftop Bar at this time, the venue will offer an alternative venue within the Hotel. This, however, is not guaranteed to be within the Rooftop Bar. The Balcony function space in 18 Knots Rooftop Bar does not have a private bar built in. If you wish to have a private bar built on the balcony, the setup is \$500.00. Alternative guests will be issued a wristband and order beverages from the main bar inside.

Smoking On Premises

Should any guests be found smoking within the venue, the Hotel will notify the organiser. Should the organiser not be present/ found, the Hotel retains the right to evict the guest from the premises.

Capacity Restrictions / Unaccounted for Guests

All function spaces at the DoubleTree by Hilton Perth Waterfront have set capacity restrictions and minimum spends stipulated, it is for this reason that the Event Manager must be aware of the total number of guests attending your function in order to keep within the property's legal requirements with regards to Responsible Service of Alcohol and Liquor License requirements. Should a large number of unaccounted for guests attend the venue, after surveilling the amount of food selected by the organiser, the Hotel possess the right to place additional last minute food orders in order to ensure the function is in line with RSA. Or if in a necessary circumstance, refuse guest entry to the function space.

Event Timings

The venue will proceed with the event as per timings listed in timing section of the event order distributed by the Event Manager. Should you wish to adjust timing on the day of your event, the Function Manager assigned to your booking retains the right to refuse should it impact the venue in any way.

Food Service Delav

Should you wish to delay food service on the day of the event without providing the kitchen with ample notice (as determined by the chef on duty), the venue has the right to deny your request. Food is prepped in keeping with the timing stipulated, thus delaying service may potentially result in the food becoming not presentable / inedible. Should a delay request be approved, new timing parameters will be advised by the chef on duty. Should food items be required to be re-prepared due to a delay request, additional costs may be involved to replace these items.

Minimum Spend Requirements

Minimum spend requirements have been clearly advised within this document or by your designated Sales Executive. Should you not reach your minimum spend requirement stipulated, the venue will charge accordingly to what is present in the Event Order document issued for approval. Unless alternative arrangements have been discussed with your assigned Sales Executive.

Deliveries / Loading Dock Use


The Hotel will not accept / sign for any deliveries that arrive at the Hotel without our prior knowledge. The property has very limited storage space available, therefore may not be able to store large quantities of collateral. All deliveries and storage requests must be discussed prior to your event date with your designated Event Manager.

Liquor Licence & RSA

The DoubleTree by Hilton Perth Waterfront is a fully licenced venue, bringing alcohol into the premises is a serious offence. If a guest is caught having brought externally purchased / acquired alcohol into the venue, the Hotel could be facing up to a \$10,000 fine, \$5,000 fine for approved manager on duty, \$2,000 fine for all individual bartenders present in addition to a mark-up on the venue's liquor licence. That being said, should any guests be found to be bringing alcohol into the venue, they will be asked to leave, and any alcohol in their possession will be confiscated.

Should any guests enter the premises already heavily under the influence of alcohol, the Hotel has the right to refuse entry.
